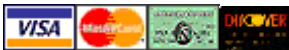

### Smart-Rig Cranes Standard Payment Terms

- U.S. orders require payment in full + shipping. Allow 14-21 days for build time plus shipping depending on your location.
- All orders received from Customers outside of the U.S., or unauthorized US businesses must be prepaid in full prior to shipment.
- All Customer orders requesting shipment outside the U.S. must be paid in full prior to the date of shipment.
- Payments for foreign orders will be accepted only in U.S. dollars.
- Late payment fees will be charged at the rate of 1.5% of the total outstanding balance per month on accounts paid later than 30 days after the invoice date.
- If any Smart-Rig Crane invoice issued to you requires any collection efforts from Smart-Rig Cranes or its agents, Customer agrees to pay all reasonable attorney fees, court costs, and any other Smart-Rig Crane expense incurred during the collection of any outstanding Smart-Rig Crane invoice.
- Warranty is valid only after full payment has been received by Smart-Rig Cranes.
- No credit will be allowed for any goods returned without Smart-Rig Cranes authorization.
- All claims for damaged merchandise to be filed with delivering carrier.
- Any and all applicable discounts Smart-Rig Cranes may have provided to a Customer for a specific order is waived and the full amount is due if Customer fails to pay any related Smart-Rig Crane invoice within 30 days of the date of the Smart-Rig Cranes invoice.
